PROVISION OF ONLINE TECHNICAL ASSISTANCE AND MONITORING ON THE UTILIZATION OF E-LIBRARY IN THE MATATAG PORTAL LEARNING MANAGEMENT SYSTEM

1. Relative to the implementation of MATATAG Portal on Learning Management System - E-Library of the Department of Education – Bureau of Learning Resources (DepEd BLR), this Office through the Curriculum Implementation Division-Learning Resource Management Section (CID-LRMS) will provide Online Technical Assistance on the Utilization of E-Library from **August 1-7, 2024, 8:00 AM – 5:00 PM.**
2. This activity aims to enroll, orient, and provide technical assistance to teachers in the MATATAG LMS to guide their students in accessing the E-Textbooks using their respective account to access the e-textbooks through interim E-Library at the MATATAG Portal.
3. The E-Library is the official online repository of MATATAG E-Textbooks, Teachers Manuals, Catch-Up-Fridays lesson exemplars, Storybooks, Special Program in Foreign Language (SPFL) Materials.
4. All Kindergarten, Grade 1, 4, and 7 teachers are expected to log-in and utilize the E-Library. Learners are also encourage to utilize the E-Textbooks pending the printing and delivery of the textbooks.
5. The CID-LRMS technical assistance will be through a help desk via Facebook school GC, email, call and text and MS teams <https://tinyurl.com/MatatagE-Library> created for this purpose.


