

SUBJECT: General Guidance for the Conduct of Monitoring Activities for the Deployment of School Nurses for the Implementation of Oplan Kalusugan sa DepEd-Healthy Learning Institutions (OKD-HLI) Program

With the ongoing project of the Health Promotion Bureau (HPB) and Cagayan Valley Center for Health Development (CHD) to augment the supply of DepEd school nurses for the implementation of the Oplan Kalusugan sa DepEd-Healthy Learning Institutions Program, the Health Promotion Bureau strongly recommends the following actions for monitoring and evaluation:

1. All school heads of DepEd-managed grade schools and high schools in Region 2 are enjoined to answer the online OKD-HLI Self-Appraisal Checklist, accessible via bit.ly/SACforNurseDeployment
2. All grade 6 learners in DepEd-managed grade schools are requested to answer the confidential Student Survey Tool, accessible online via bit.ly/OKDHLLI-SHS
3. The above monitoring tools should be completed by **August 31, 2024**.

The HPB recommends this guidance be disseminated with the Department of Education Regional Office No. 2.
