

This Bureau, through the Education Assessment Division (EAD), will conduct an **Item Writing Workshop on various National Assessment Programs**. This workshop aims to develop test items for National Assessment Programs vis-a-vis the K to 12 Basic Education Program.

DepEd Order No. 55, s. 2016: Section 7 (Test Development Process) on the Policy Guidelines on the National Assessment of Student Learning for the K to 12 Basic Education Program specifies that in the test development process, workshops shall be conducted for the construction of items and shall be done by a pool of item writers, including field personnel. Teachers, who are curriculum implementers and facilitators of learning, are eligible participants in this workshop to develop items based on the existing curriculum.

6. collaborative and committed in completing item writing outputs.




