

ADDENDUM TO RM 441 s. 2024 RE CATCH-UP IN-PERSON LEARNING RECOVERY THROUGH PROJECT BANGON-ARAL

To: School Division Superintendents

1. Relative to Regional Memorandum No, 441 s. 2024 re Catch-Up In-persons Learning Days to Recover Lost School Days Due to Typhoons, the following are the addends:

- a. all teaching and non-teaching personnel involved in this activity particularly during week-ends and extended hours beyond official working hours shall apply the DepEd Order No. 005 s. 2024 (Rationalization of Teachers' Workload in Public Schools and Payment of the Teaching Overload); DO 13 s. 2024 (Revised Guidelines on the Grant of Vacation Service Credits for Teachers); and or CSC Department Circular No.352 s. 2004 (CSC and DBM Joint Circular No. 2 s. 2004, "Non-Monetary Remuneration for Overtime Services Rendered").
- b. a parent's consent and waiver must be issued and collected for all learners involved in this activity. This ensures that the parents or guardians are fully informed and provide their approval for their children's participation.

2. An orientation meeting shall be conducted on November 19, 2024 at 1:30 pm via CLMD Microsoft Teams to be participated in by the SDSs, ASDSs, CID Chiefs, EPSs and PSDSs.

3. All pertinent provisions of DepED Memorandum No. 291 s. 2008 shall remain in force.
